#### Session Ia

**Fostering Responsible Leadership through Education for a Peaceful Future** *Exploring values-based leadership rooted in character, compassion, and moral clarity to bridge divides and heal wounds.* 

### Dr. Aicha Bacha, European Center for Development and Geostrategic Studies and Analysis President, Belgium

Dr. Aicha Bacha's speech on the anniversary of UN Resolution 1325 addresses the issue of youth radicalization, drawing from her doctoral research on Belgian jihadists of Moroccan descent. Her study began in 2012 after meeting mothers whose sons had left to fight in Syria. Over six years, she followed fifty-two mothers to understand how family violence and social conditions contribute to radicalization. The findings revealed that many mothers had endured lifelong violence and humiliation, which became unconsciously transmitted to their children as emotional and behavioral patterns. These children, often marginalized and angry, became vulnerable to extremist ideologies offering identity and purpose. Dr. Bacha emphasizes that radicalization is not confined to any single community but arises from a chain of social and familial vulnerabilities. She advocates for "parenting schools" to strengthen family bonds and emotional education, urging collective responsibility to heal generational trauma and prevent future radicalization.

# Ms. Nada Harward, Honorary Consul, Bath Spa University, Associate Lecturer, Lebanon

The speech calls for reviving and redefining the core values of the United Nations amid global crises, moral decline, and weakened multilateralism. It highlights the erosion of international law, financial strain, and the UN's shrinking capacity to promote peace, justice, and human rights. Once a symbol of global cooperation, the UN now faces downsizing and diminishing influence, threatening the ideals it was built upon. The text revisits milestones like Kofi Annan's reforms and the Sustainable Development Goals, contrasting their initial hope with today's

geopolitical fragmentation and loss of moral compass. It explores reforming the UN Charter under Article 109, led by the "109 Coalition," as a potential yet uncertain path toward renewal. The speech urges a return to the UN's original mission as a broker of peace, calling for visionary leadership—possibly from a woman Secretary-General—and ends with hope that compassion and solidarity can restore global harmony.
